

Ground Handling Charges - USA



Effective March 28, 2010

Air Waybill Amendment Fee (CCA)

\$25.00 if amended at agent's/shipper's request, or if an irregularity is found by the carrier or its agent resulting in an incorrectly completed air waybill.

Air Waybill Preparation Fee

\$25.00 per consignment (inclusive of shipper's export declaration if required).

Bank Hold Fee (for Bank Releases)

\$20.00 per consignment.

BIP Charges

Products of animal origin with a transit time of 12 hours or more in the UK are subject to a veterinary check and Border Inspection Post (BIP) Charges. Please check with us at time of booking.

Certified Manifest/Air Waybill Fee

\$20.00 per manifest/air waybill.

Charges Collect Fee

\$10.00 minimum charge - or - 5% of the weight and valuation charge, whichever is greater.

Dangerous Goods Fee

\$80.00 per UN/ID number.

*If a DG shippers declaration is attached, then the DG Fee is to be charged.

Disbursement Charges

USA Gateway to annotate AWB with appropriate disbursement charges: \$20.00 minimum charge per air waybill - or - 10% of the disbursement amount, whichever is greater. The same charge will be assessed for the collection of advance charges from the consignee for services performed prior to air transportation except for:

Disbursement amounts less than \$50.00 in which case an \$8.00 charge will be assessed.

Airfreight charges are less than \$100.00 in which case disbursement amounts up to \$100.00 are permitted. This over-rides the general rule of the disbursement amount not exceeding the airfreight charge.

Import Service Charge

\$35.00 per Master Air Waybill (AWB).

Consolidation Breakdowns

\$35.00 per Master AWB plus \$35.00 per House AWB.

\$35.00 only for back-to-back consolidations or consolidations delivered on a Master AWB Waybill.

Any changes in consolidation breakdowns must be received in writing by BAWC or its agents a minimum of one hour prior to flight arrival.

Import Service Charge – Offlines

▪ \$35.00 for any shipments transiting to a BA offline point within the USA, and picked up at a Forward Air terminal.

Live Animal Special Handling Fee

Minimum freight charge of \$250.00 per consignment Export Handling Fee of \$75.00 per consignment.

Air waybill preparation fee of \$25.00

LHR/LGW Import Handling Fee of \$185.00 per consignment held up to 48 hours. Fee collected upon delivery in the UK.

LHR/LGW ARC Transit Fee of \$185.00 per consignment collected upon departure from USA.

Pets With Passports Fee

Applies to domestic cats & dogs/UK terminating only/Not available into other UK destinations.

PTS charge of \$500.00 is inclusive of Export (including \$25 AWB preparation fee) and Import fees.

Each additional animal traveling from the same household on the same AWB is charged \$50.00.

Post Entry Fee

\$20.00 per post entry plus \$25.00 for the first piece plus \$5.00 per each additional piece.

Screening Charges

From December 21, 2009, screening charge of \$0.05 per kilo based on actual weight with a maximum of \$100.00. Contact your local BAWC office for a list of exemptions.

Sky Kennel Fees

Kennels not meeting IATA standards will be replaced with IATA-complaint kennels. The shipper is responsible for the cost of the replacement: Kennel prices will vary according to the size of the animal. In addition, there is a \$50.00 service charge for the replacement.

Storage Charges

Charges are applied to freight not collected 48 hours after aircraft arrival, excluding Sundays and Government holidays. Minimum charge is \$25.00.

Valuables (VAL) Security Handling Fee

\$50.00 per consignment on designated VAL flights -
or - \$150.00 per consignment non-designated VAL
flights (prior arrangement required). *There is an
additional fee of \$100.00 if transferring between
LHR/LGW.

Terms & Conditions

All charges should be applied in USD.

Other charges may be applied as required by
governments, airports or other bodies of authority.

All charges will be applied to the chargeable weight of
a consignment.

**Any incidental charges incurred by British Airways or
British Airways World Cargo on a consignment may
be assessed against the agent and/or consignee**
